# TERMS AND CONDITIONS FOR STALL HOLDERS

# 1. Arrival

- 1.1 Entry to the site is via the Banksia Avenue gate.
- 1.2 The gates to the venue open at 7:00am.
- 1.3 By 8:45am, all stalls must be established and all vehicles MUST leave the site.
- 1.4 Should a vehicle be required to remain on site, an application must be made to the Stalls Organiser, prior to the event.
- 1.5 No late arrivals will be admitted entry to the site & stall fees will **NOT** be refunded on the basis that late arrival precludes admission to the site.
- 1.6 Stallholders may NOT arrive without PRIOR approval from event organisers.
- 1.7 Payment is due at the time of application. NO payments will be accepted on the day of the event.

#### 2. Departure

- 2.1 Stallholders are to operate their stalls between 9:00am and 3:00pm.
- 2.2 No vehicle may re-enter the site prior to 3pm, except with the prior approval of the Sutho Cops & Rodders Organisers.

# 3. Standard of Conduct

- 3.1 All proprietors and staff should conduct themselves in a courteous and respectful manner at all times. Rude, abusive or other disruptive or offensive conduct is not acceptable.
- 3.2 Stall proprietors and staff are not to enter into any debate or argument with any visitor or other stallholder. If any stallholder creates or finds themselves in a situation that is liable to cause embarrassment, dispute of any kind or problem to others, they must contact the Stalls Organiser immediately.
- 3.3 The Sutho Cops & Rodders Road Safety & Car Show Organisers may, at their absolute discretion, remove from the event any stallholder, whom in their opinion is behaving in a manner that falls below the accepted standard of decent and appropriate behaviour.
- 3.4 All stallholders are to comply with instructions given by the Stalls Organiser.

# 4. Weather

- 4.1 The Sutho Cops & Rodders Road Safety & Car Show may subject to inclement weather.
- 4.2 It is Stallholders responsibility to bring adequate cover in case of rain.

# 5. Insurance and Liability

- 5.1 It is a condition of entry that stall holders have a current Public Liability Insurance Policy for a minimum \$10m. A copy of the **Public Liability Insurance** certificate of Currency is to be attached to the "Registration for Stall Site Hire" form. Applications will not be considered if the policy document is not attached.
- 5.2 For those stallholders selling food and drinks, the policy must be extended to include goods sold under the Products Liability section of the required Public Liability policy.
- 5.3 The Stallholder agrees not to make any claim against the Sutho Cops & Rodders Road Safety Car Show organisers for any loss or damage, or loss of profits, howsoever caused.

# 6. Stall Operation

- 6.1 The organiser cannot guarantee specific sites. Site allocation will be on a "first come, first served" basis at the discretion of the event organisers.
- 6.2 Limited electric power is available. Stallholders are encouraged to supply their own power with a silenced generator.
- 6.3 All electrical equipment and electrical leads must have been inspected and tagged by a licensed electrical contractor, with an expiry date clearly labelled. Leads that have surpassed the expiry date will not be allowed to be used.
- 6.4 The stall holder warrants that all of their equipment complies with Australian Safety Standards in accordance with Work Health and Safety and other applicable legislation.
- 6.5 Stall holders found (upon spot checks by the organisers) to have defective electrical equipment and/or leads will not be permitted to operate and no refund will be given.
- 6.6 Site rubbish bins are for visitor use. Stallholders must remove all material and rubbish from their site before departure, leaving a clean site.

- 6.7 All loose items must be secured in a safe manner. This includes tents, gazebos, helium bottles and tables, which must be secured with weights so that objects cannot be blown away by the wind and/or attending helicopters.
- 6.8 The stallholder acknowledges that the Sutho Cops & Rodders Road safety and car Show is an Alcohol Free Zone and that the consumption of illicit drugs or alcohol during the event is strictly forbidden.

# 7. Stall Content

- 7.1 Food items proposed to be sold must be disclosed in the application form. Persons selling food items other than those disclosed may be refused permission to operate.
- 7.2 No stallholder may operate a petition, lobby, or form of demonstration etc from their Stall.
- 7.3 The following items are banned from stalls and prohibited from sale:
  - a) Products that do or may infringe copyright laws;
  - b) Weapons of any kind, including, but not limited to: replica guns (including plastic guns, pellet guns, water pistols, cap guns),ornamental copies (e.g. Ninja swords),knives and swords (including pen knives) and martial art supplies;
  - c) Products displaying explicit and hardcore images or coarse language;
  - d) Fake cigarettes;
  - e) Fuel type fire lighters (e.g. Zippo);
  - f) Horns and trumpets;
  - g) Pressure pack fart gas & stink bombs;
  - h) Drug related goods (including cocaine kits, water pipes, bongs, hemp etc);
  - i) Water bombs;
  - j) Silly string;
  - k) Fireworks and crackers;
  - I) Laser pointers; and
  - m) Any object or item capable of shooting a projectile.
- 7.4 The list of banned items extends to items sold in show bags.
- 7.5 The Sutho Cops & Rodders Road Safety & Car Show may, at its discretion, order the removal of an item from sale, which is considered to be, or be comparable to a banned item.
- 7.6 Stallholders selling any item listed in Clause 7.3 or deemed to be prohibited at the Event Organisers discretion exercisable under Clause 7.5 may be excluded from the event. The stallholder selling the item may be subject to criminal investigation and/or prosecution.

# 8. Food Stall Operator Conditions

- 8.1 The current Food Safety Standards require food businesses involved in temporary events to notify NSW Health of their business details, nature of food business and location of temporary premises.
- 8.2 Food stall operators must provide their NSW Health Temporary Food Event Notification Reference Number on the front page of this application. **Community and Non-Profit groups may be exempt from this requirement.** Please go to <u>www.foodnotify.nsw.gov.au</u> for exemption criteria.
- 8.3 All food stallholders agree to comply with the NSW Food Authority Food handling Guidelines for temporary Events (Issued 30/6/2006), the "Sutherland Shire Council Temporary Food Premises Code" and with any other applicable laws.
