Insp Bell:

Inspector Bell provided the group with the Police briefing, commencing with the latest crime maps showing the frequency and distribution of Break and Enter offences in recent weeks. He also went on to outline some recent notable arrests made within the LAC, before taking questions from the floor.

Ian St. VINCENT asked about a Break and enter that occurred on 17/1/10 at Lindfield Public School. Has it been reported? He also reported that young persons were congregating at the Lindfield Public School on Friday/Saturday nights and underage drinking was occurring.	Insp Bell- Will find out about the B&E report. And assured taskings would be adjusted to include patrols of Lindfield Public School on those nights.
Inquiry re: fingerprint car. Is it still going?	Insp Bell reported that the sponsored car had ceased due to lack of funds required. Also mentioned that this

	<p>did not mean no fingerprinting was being done, only that one less car was available now, leaving two cars for the use of three persons when they were all rostered, which was rarely. Explained the sharing model for FSG SOCO's with Kuring Gai , Northern Beaches and Harbourside.</p>
<p>Issue raised re Firearms licensing / control, with a request for a guest speaker on the subject for a future meeting. Also mentioned the Use of Tazers by criminals due to recent report of one being used locally in an Armed Robbery.</p>	<p>Insp Bell reported that this was rare and also stated the device described appeared to be what was once known as a Personal Protection Device and not an actual Tazer. A suitable speaker will be arranged for an upcoming meeting.</p>
