### PLEASE READ THE FOLLOWING INFORMATION PRIOR TO FILLING OUT THIS FORM

This form **must** accompany a Licence Application form. This genuine reason form applies to a person who wishes to participate in target shooting competitions and activities. The applicant must be a current member of a shooting club approved by the Commissioner.

Please note the issuance of a Firearms Licence authorises the licensee to possess and use only the firearms permitted by the particular category of licence held eg. a Category B licence does not entitle the holder to possess or use a Category A firearm.

Possession and ownership of a firearm requires the holding of an appropriate firearms licence **and** registration of the firearm.

The Genuine Reason of Sport/Target Shooting allows for the application of a Category A, B, C and /or H firearms licence only.

#### Category A, B or H only

Certification of current membership of an approved Target Shooting Club by a Club Official must be provided **OR** attach official club documentation which identifies your membership details.

#### Category C (Special) Clay Target only

If applying for a Cat C (Special) Clay Target Sport/Target Shooting firearms licence you must supply certification by a Club Official, of current membership of a Clay Target shooting club affiliated with the Australian Clay Target Association **AND** a certificate from a Medical Practitioner advising of the physical reasons that necessitate the use of a Category C firearm in Clay Target shooting competitions.

Category A

Air rifles, rimfire rifles (not self-loading), shotguns (not pump action or self-loading) and shotgun/rimfire combinations.

Category B

Muzzle loading firearms (not pistols), centre-fire rifles (not self-loading) and shotgun/centrefire combinations.

Category C (Special)  
(Clay Target Shooting Only)

Self-loading or pump action shotguns (maximum magazine capacity of 5 rounds and limited to 2 rounds loaded at any one time) and not covered by firearms described in items 6, 10, 11 of Schedule 1 of the *Firearms Act 1996*. The special category C certification on the back of this form must be completed by a Club Official and a Medical Certificate must be supplied.

Category H

Pistols (including blank fire pistols, black powder & air pistols) excluding prohibited pistols.  
Prohibited pistols include a pistol with a calibre of more than .38 inch (high calibre), a self-loading pistol with a barrel length of less than 120mm or a revolver or a single shot pistol with a barrel length of less than 100mm (specialised target pistol).
