Instructions for a Permit to Acquire a Handgun

A.B.N. 43 408 613 180

This application form is for current licence holders who wish to acquire a handgun.

YOU CAN ONLY PURCHASE ONE HANDGUN PER APPLICATION. A permit is valid for 90 days.

PLEASE NOTE: Applications for a Permit to Acquire from holders of a Probationary Pistol Licence will not be considered unless the applicant has held their probationary licence for a period of six months. Restrictions on the type of handguns permitted also apply.

Instructions to all applicants – follow these steps to complete your application

SECTIONS A, B APPLICANT'S DETAILS

You must enter your licence or permit number and you must complete either the Personal Details or Business / Club / Government Agency Details Section depending on who holds the licence or permit.

SECTION C SAFE KEEPING ADDRESS OF FIREARMS

You MUST provide an address where this firearm is stored when not in use. If this address is the same as your residential address mark the box provided with an "X".

SECTION D HANDGUN TYPE

Indicate the type of handgun you wish to purchase by marking the appropriate box with an "X". **Remember, you can only apply to purchase one handgun per application.** You may only acquire a handgun as authorised by your licence/permit and approved under this application.

The meaning of a Prohibited Pistol is defined in Section 4C of the *Firearms Act 1996*.

The meaning of a Specialised Target Pistol is defined in Section 16B of the *Firearms Act 1996*.

GOOD REASON TO ACQUIRE A HANDGUN

This reason must be in agreement with a genuine reason and related firearm category for which you hold a handgun licence. Signing the declaration confirms that your good reason for acquiring the firearm is directly related to the genuine reason and category of your current firearms licence.

SECTION E CLUB CONFIRMATION

If you are a Target Shooter or a Collector of post 1946 handguns, your club official needs to complete the appropriate details in this section. Target shooters please specify the type of shooting activities the handgun will be used for.

SECTION F FEE EXEMPTION

Pensioners are exempt from fees for Permits to Acquire for all categories of firearms, if they hold a Current Pensioner Concession Card issued by the Department of Social Security or Department of Veterans Affairs, or receive a Disability Pension or Armed Services Widows Pension from the Department of Veterans Affairs. Include a copy of your Concession or Pension Card if you have not previously obtained a fee exemption from the Firearms Registry, or the document supplied is no longer current.

Note: Health Care Cards are not accepted.

DECLARATION

Check the details on the application form. If all details are correct, sign and date the application.

Once you have completed the application you must, unless you are fee exempt, attach a cheque or money order, or complete the credit card authority below, for \$30- DO NOT SEND CASH.
