## Application for a B709 Police Confirmation for Handguns - Category H Firearms

This form must accompany the **B709 Individual/Business Non Dealer Application form** and is used for obtaining police confirmation and certification for importation of category H firearms (pistols and revolvers) & handgun parts. For unregistered firearms, your B709 Certificate will not be issued until you apply for a Permit to Acquire the firearm. If you are also importing ammunition, you must complete the ammunition form, in addition to this form.
