## Minor's Firearm Permit Legitimate Reason Form

### PLEASE READ THE FOLLOWING INFORMATION PRIOR TO COMPLETING THIS FORM

This is an **interactive** form and applies to a person who is a minimum of 12 years of age, but not more than 18 years of age, who wishes to possess and use firearms while under the supervision of a person holding a firearms licence of the relevant category.

Please complete all sections, print this form and submit with the P637 'Application for a Minor's Firearm Permit' form and any supporting documentation to the **Firearms Registry, Locked Bag 5102, Parramatta NSW 2124.**

### 1. FIREARMS SAFETY TRAINING

- Minor's Firearms Training Permit for Categories A, B or C.** You must complete an approved Firearms Safety Training Course and provide a copy of the certificate issued upon successful completion of the course **with your application.**
- Minors Target Pistol Permit - Category H.** You must complete a 'Pistol Safe Handling Course' conducted by or on behalf of the target pistol club of which you are a current member and provide a copy of the certificate issued upon successful completion of the course **with your application.**

### 2. CATEGORY C MINOR'S FIREARM TRAINING PERMIT

I confirm that the applicant is a current member of the club named below which is associated with the Australian Clay Target Association or other approved body. I also confirm that due to physical reasons, the applicant requires to possess and use a pump action or self-loading shotgun to participate in clay target shooting competitions.

This declaration must be completed by a Parent or Legal Guardian and gives consent to obtain a Minor's Firearms Permit.

#### FURTHER INFORMATION

It is a serious offence under the *Firearms Act 1996* to make a statement or provide information in relation to an application that is false or misleading. By signing the Declaration on the P637 firearms permit application form, the applicant is certifying that ALL the information supplied in relation to this application is true and correct.

If a person under the age of 18 years contravenes any provision of the Act or the Regulation, each parent of the person is taken to have contravened the same provision if the parent knowingly authorised or permitted that contravention. Parents signing the Declaration on this legitimate reason form are confirming that all the details in the application and legitimate reason forms are true and correct.

#### CHECKLIST - Make sure you have supplied ALL of the following required information:

##### **All applicants are required to provide:**

- A completed P637** 'Application for a Minor's Firearm Permit' form
- A Legitimate Reason** form with the relevant sections completed:
  - Proof of Identity**
  - Firearms Safety Training Certificate relevant to category of permit sought
  - Category AB** - A copy of your club membership, *if applicable*
  - Category C** - club confirmation of membership and confirmation of physical reason for category C
  - Evidence from medical practitioner for Category C Firearms Safety Training Permit
  - Category H** - A copy of your club membership
  - Parent / Guardian Declaration completed
  - Guardian documentation to prove legal guardian status
  - Fee \$75 (cheque, money order or credit card authority), with the application.** Two fees apply if the application is for a Minor's Firearms Training Permit (A, B or C) and Minor's Target Pistol Permit (H)
