## Application for a B709 Police Confirmation for an Individual or for a Business - Non Dealer

This form should be used by an Individual or Business (non-dealer) making application for a police confirmation and certification for importation of firearms, paintball markers, firearm parts, ammunition or weapons. The B709 Certification will only be issued where the applicant is authorised to possess the article/item in NSW by a firearms licence or permit or where no such authorisation is required. This form must be accompanied by the relevant form for the item being imported; ABC firearms & parts, H firearms & parts, paintball markers & parts, ammunition or weapons. Fields bordered in **RED** are mandatory.
