PLEASE READ THE FOLLOWING INFORMATION PRIOR TO COMPLETING THIS FORM

This is an **interactive** form and applies to a person making application to possess and use a black powder cannon in historical re-enactments and displays. The cannon can only be fired (blank fire only) for purposes of demonstrating its use.

1. EVIDENCE OF LEGITIMATE REASON FOR THIS PERMIT

The Commissioner must not issue a permit unless satisfied that the applicant has a legitimate reason for the permit. Provide information below on the reason you need possession and use of a cannon, including the purpose for acquiring the cannon.

2. CLUB MEMBERSHIP

You must be a current member of an historical society or club whose purpose includes the preservation and demonstration of historical weapons.

3. FIREARMS SAFETY TRAINING

If you have never held a firearms licence or permit in NSW, or you do not currently hold an equivalent issued firearms licence or permit interstate, you are required to complete firearm safety training for longarms.

A certificate of successful completion of an approved firearm safety training course for longarms attached (*if applicable*).

4. CANNON SAFE KEEPING FACILITIES

Provide information below on your arrangements for safe keeping and storage of a cannon at the firearm safe keeping address nominated in your Firearms Permit application form.

5. DETAILS OF THE CANNON

Provide details of the cannon including calibre, make, model, description of size (if possible attach a photograph of the cannon).

CHECKLIST

Make sure you have supplied ALL of the following required information:

All applicants are required to provide:

- A completed P634** 'Application for a Firearms Permit' form
- Proof of Identity** (if no other NSW firearms licence or permit is held or has been held).
- A Legitimate Reason** form with the relevant sections completed:
 - Evidence of legitimate reason for permit
 - Membership number or letter on letterhead from the historical society or club of which you are a member.
 - Firearm safety training certificate, *if applicable*
 - Cannon safe keeping facilities
 - Details of the cannon and photograph of the cannon if possible
 - Location cannon will be used & public safety measures
 - Display location
 - Fee \$75 (cheque, money order or credit card authority), with the application**
