This permit does not authorise possession and use of a firearm for any other hunting activities except those specified.

It is a serious offence under the *Firearms Act 1996* to make a statement or provide information in relation to an application that is false or misleading. By signing the Declaration on your firearms permit application form, you are certifying that ALL the information supplied in relation to this application is true and correct.

If this permit is approved and you have indicated you are importing firearms for competition purposes, a B709 Police Confirmation will be issued to allow the release of firearms from Australian Customs upon your arrival in Australia.

#### CHECKLIST - All applicants are required to provide:

- A completed P634** 'Application for a Firearms Permit' form
- A Legitimate Reason** form with the relevant sections completed, including:
  - Arrival & Departure details
  - Contact details whilst in NSW
  - Copy of Passport
  - Certified copy of licence or permit from your country of residence or police clearance certification completed
  - Details of firearms to be imported (including ammunition and firearm parts), if applicable
  - A letter from the safari tour organiser **OR** a letter on club letterhead from the club organising the hunting activities with location, dates etc
- Fee AUD\$75 (cheque, money order or credit card authority), with the application**
