- **Proof of Identity** (if no other NSW firearms licence or firearms or weapons permit is held or has been held).
- O **Individual applicants** A passport sized colour photo of yourself <u>endorsed and signed</u> on the back by a JP or serving police officer '*This is a true photo of NAME*'.
- O Business Applicants Business Declaration completed
- **A Genuine Reason** form with the relevant sections completed.
  - O Details of the laser pointer/s required (quantity and description).
  - O Evidence of your genuine reason for obtaining a Laser Pointer Permit.
  - O Details of the location the laser pointer is to be used and activities to be conducted.
  - O Details of the safe keeping arrangements for laser pointers.
