

CUSTOMS SCHEDULE 6 ITEM NUMBER

The following firearms, firearms parts, ammunition & components of ammunition are relevant to an application for a 'Police Certification Test' to the Firearms Registry using a B709 application form.

Where requested, please enter the ITEM No on the B709 application & accompanying forms. If you require guidance to itemise goods, please contact Customs for assistance prior to making application.

CATEGORY A FIREARMS

Any of the following firearms, other than a firearm:

(a) that is:

- (i) fitted, whether by original design or by modification, with a folding or detachable stock; and
- (ii) capable of being fired when the stock is in the folded position or removed; or

(b) that is substantially the same in appearance as a fully automatic firearm.

Schedule 6 Item No	Description
1	Air rifle. Rimfire rifle (other than self-loading). Shotgun (other than pump action, lever action or self-loading). Shotgun/rimfire rifle combination.
1A	An imitation of a firearm.

CATEGORY B FIREARMS

Any of the following firearms, other than a firearm:

(a) that is:

- (i) fitted, whether by original design or by modification, with a folding or detachable stock; and
- (ii) capable of being fired when the stock is in the folded position or removed; or

(b) That is substantially the same in appearance as a fully automatic firearm.

Schedule 6 Item No	Description
2	Muzzle-loading firearm (other than pistols). Centre fire rifle (other than self-loading). Shotgun/centre-fire rifle combination. Lever action shot gun with a magazine capacity of no more than 5 rounds..
2B	Firearm part of, or for, a firearm to which item 1 or 2 applies, other than a firearm part that is capable of converting, either on its own or in conjunction with other parts, a firearm to a semi-automatic or fully automatic firearm.

CATEGORY C FIREARMS – PRIMARY PRODUCERS ONLY

Any of the following firearms, other than a firearm that is:

- (a) fitted, whether by original design or by modification, with a folding or detachable stock; and
- (b) capable of being fired when the stock is in the folded position or removed.

Schedule 6 Item No	Description
3	Self-loading rimfire rifle: (a) without a firearm magazine; or (b) fitted with a firearm magazine of a capacity of no more than 10 rounds.
3	Self-loading shotgun; (a) without a firearm magazine; or (b) fitted with a firearm magazine of a capacity of no more than 5 rounds.
3	Pump action shotgun: (a) without a firearm magazine; or (b) fitted with a firearm magazine of a capacity of no more than 5 rounds.

FIREARM PARTS

Schedule 6 Item No	Description
4	Firearm part of, or for, a firearm to which item 3 applies, other than a firearm part that is: (a) a firearm part of, or for, a firearm to which item 1, 2 or 9 applies; or (b) capable of converting, either on its own or in conjunction with other parts, a firearm to a fully automatic firearm.

CATEGORY D FIREARMS

Importation of a Category D firearm (Schedule 6 item 6), a part (item 7) for a category D firearm requires permission from the Attorney General.

CATEGORY H FIREARMS – HANDGUNS AND REVOLVERS

Any of the following firearms (including complete, but disassembled or unassembled, firearms), unless the firearm:

- (a) has a fully automatic firing capability; or
- (b) is substantially the same in appearance as a sub-machine gun, a machine pistol or a handgun that has a fully automatic firing capability.

9	Pistol (including a blank fire pistol and air pistol). Muzzle loading handgun;
9B	A frame or receiver of, or for, a firearm to which item 9 applies
10	Firearm part of, or for, a firearm to which item 9 applies, other than: (a) a frame or receiver; or (b) a firearm part of, or for, a firearm to which item 1 or 2 applies; or (c) a firearm part that is capable of converting, either on its own or in conjunction with other parts, a firearm to a fully automatic firearm
Firearm accessories (item 11) for a firearm mentioned in item 9 must have permission from the Attorney General for importation.	

PAINTBALL FIREARMS AND PARTS

Any of the following firearms, unless the firearm:

- (a) has a fully automatic firing capability; or
- (b) is substantially the same in appearance as a fully automatic firearm.

14A	Paintball marker designed exclusively to fire paintballs other than a paintball marker: (a) that is substantially the same in appearance as a fully automatic firearm; or (b) to which a firearm accessory is attached or is integral. Firearm part of, or for, a paintball marker mentioned in this item.

FIREARM MAGAZINE

Schedule 6 Item No	Description
17	Firearm magazine, other than a firearm magazine to which item 15, 16 or 16A applies, whether or not attached to a firearm.

The following magazines require permission from Attorney General

Schedule 6 Item No	Description
15	Detachable firearm magazine, having a capacity of more than 5 rounds, for: (a) semi-automatic shotguns; or (b) pump-action shotguns; or (c) fully automatic shotguns; whether or not attached to a firearm.
16	Detachable firearm magazine, having a capacity of more than 10 rounds, for: (a) semi-automatic rimfire rifles; or (b) semi-automatic, pump-action or lever action centre-fire rifles; or (c) fully automatic firearms, other than fully-automatic shotguns; whether or not attached to a firearm.
16A	Detachable firearm magazine, having a capacity of more than 15 rounds, for repeating action centre-fire rifles other than a pump-action or lever action centre-fire rifle, whether or not attached to a firearm.

AMMUNITION

Ammunition for any firearm to which item 1, 2, 3, 6, 9, 12 or 14A applies, other than ammunition to which item 19 applies.

A component of ammunition for a firearm to which item 1, 2, 3, 6, 9 or 12 applies, other than a component to which items 21 and 22 apply.

The following ammunition requires approval from the Attorney General

Ammunition of the following kinds for a firearm to which item 1, 2, 3, 6, 9 or 12 applies:

(a) ammunition that has, as part of the components (either assembled or separate), a projectile known as any of the following kinds:

- (i) tracer;
- (ii) frangible;
- (iii) explosive;
- (iv) incendiary;
- (v) armour piercing;
- (vi) penetrator;
- (viii) sabot light armour piercing (SLAP);
- (ix) flechette (being a combined collection of arrows or spears);

(b) handgun ammunition that is designed, advertised or capable of defeating:

- (i) soft body armour; or
- (ii) opaque or glazed bullet resistant material; and

(c) an electro-shock cartridge.
