This is an **interactive** form and applies to a person making application to possess and use a paintball gun only on an approved paintball field operated by the holder of a Permit to Conduct Paintball Games.

Please complete all sections, print this form and submit with the P634 'Application for a Firearms Permit' form and any supporting documentation to the **Firearms Registry, Locked Bag 1, Murwillumbah NSW 2484**.

1. EVIDENCE OF LEGITIMATE REASON FOR THIS PERMIT

The Commissioner must not issue a permit unless satisfied that the applicant has a legitimate reason for the permit. Provide information below on the reason you need to possess and use a paintball gun.

2. FIREARMS SAFETY TRAINING

If you have never held a firearms licence or permit in NSW, or you do not currently hold an equivalent issued firearms licence or permit interstate, you are required to complete firearm safety training for longarms.

- A certificate of successful completion of an approved firearm safety training course for longarms attached (*if applicable*)

3. PAINTBALL GUN SAFE KEEPING FACILITIES AND REQUIREMENTS

Provide information below on your arrangements for safe keeping and storage of paintball guns at the firearm safe keeping address nominated in your firearms permit application form.

- The safe storage facilities nominated in my 'Application for a Firearms Permit' P634 form comply with the requirements applicable to the paintball guns I wish to purchase or own.

- I have a pump-action paintball gun which will be stored according to the requirements of section 40 of the *Firearms Act 1996* - Level 1 Safe Storage

- I have a semi-automatic paintball gun which will be stored according to the requirements of section 41 of the *Firearms Act 1996* - Level 2 Safe Storage

All applicants are required to provide:

- A completed P634** 'Application for a Firearms Permit' form
- Proof of Identity** (*if no other NSW firearms licence or permit is held or has been held*).
- A Legitimate Reason** form with the relevant sections completed:
 - Evidence of legitimate reason for permit
 - Firearm safety training certificate, *if applicable*
 - Paintball gun safekeeping facilities and requirements

If approved you will be sent a photographic advice to attend the RTA to have your permit card issued.
