1. EVIDENCE OF INHERITED FIREARM
Evidence that the firearm was inherited within a six month period preceding the application being made (eg. Will or Statutory Declaration) attached.
Note: If more than six months has elapsed, evidence will be required to demonstrate exceptional circumstances which would warrant the exercise of the Commissioner's discretion to extend the six month period (eg. Will held up in probate).
2. DETAILS OF THE FIREARM OR MATCHED PAIR OF FIREARMS

3. FIREARMS SAFETY TRAINING

Attach confirmation from a licensed firearms dealer that the firearms have been rendered inoperable and how this was
achieved.

By signing the Declaration on your firearms permit application form, you are certifying that ALL the information supplied in relation to this application is true and correct.
DO NOT SEND PAYMENT WITH THIS APPLICATION. If approved you will be sent a photographic advice to attend the RTA to have your permit card issued and make payment at that time.

Evidence that the firearm or matched pair of firerarms were inherited
Oetails of the firearm/s, including registration certificates OR a Permit to Acquire a Firearm application form
Firearm safety training cetificate, if applicable
O Details of firearm safe keeping facilities
Certification from Firearms Dealer
If applicable, evidence to demonstrate exceptional circumstances to extend the six month period (if more than six months has elapsed since the firearm was inherited).
