## Permit to Authorise Storage of Firearms in NSW Legitimate Reason Form

### PLEASE READ THE FOLLOWING INFORMATION PRIOR TO COMPLETING THIS FORM

This is an **interactive** form and applies to interstate licence or permit holders who wish to store firearms in NSW on a permanent basis. Firearms must be registered in the State or Territory of residence.

Please complete all sections, print this form and submit with the P634 'Application for a Firearms Permit' form and any supporting documentation to the **Firearms Registry, Locked Bag 5102, Parramatta NSW 2124.**

### 1. FIREARM SAFE KEEPING FACILITIES AND INSPECTION EVENT NUMBER

### 2. EVIDENCE OF LEGITIMATE REASON FOR THIS PERMIT

The Commissioner must not issue a permit unless satisfied that the applicant has a legitimate reason for the permit. Provide information below on the reason you need to store firearms in NSW.

### 3. FIREARM DETAILS

In addition to being the holder of a firearms licence or permit interstate, the firearms must be registered to your interstate firearms licence or permit. Provide information below on the number and types of firearms to be stored and attach a registration certificate for every firearm to be stored in NSW.

#### 4. INTERSTATE LICENCE OR PERMIT DETAILS AND ACKNOWLEDGEMENT

To be issued a Permit to authorise storage of firearms in NSW, you must be the holder of a firearms licence or permit in the State or Territory in which you reside. You must also inform the interstate Firearms Registry of the type and number of firearms you intend on storing in NSW.

- Attach a copy of your interstate firearms licence or permit.
- Attach a letter from your jurisdiction (interstate Firearms Registry) acknowledging that you have notified them of the type and number of firearms to be stored in NSW.

#### FURTHER INFORMATION

It is a serious offence under the *Firearms Act 1996* to make a statement or provide information in relation to an application that is false or misleading. By signing the Declaration on your firearms permit application form, you are certifying that ALL the information supplied in relation to this application is true and correct.

As advised in this legitimate reason form, to be issued a Permit to Authorise Storage of Firearms in NSW you must be the holder of a firearms licence or permit in your State or Territory of residence and the firearms must be registered to that licence or permit. Applications made where the applicant is not licensed interstate and/or the firearms are not registered to that licence or permit, will not be issued.

**CHECKLIST** - Make sure you have supplied ALL of the following required information:

**All applicants are required to provide:**

- A completed P634** 'Application for a Firearms Permit' form
- Proof of Identity (certified copies)** (if no other NSW firearms licence or permit is held or has been held).
- A Legitimate Reason** form with the relevant sections completed:
  - Firearm safe keeping address in NSW
  - Firearm safe storage Inspection Event Number
  - Details of whether the safe storage location of the firearm will be vacant and if so, what additional security measures will be in place to reduce the risk of firearm theft
  - Reason for storage of interstate registered firearms in NSW
  - Details of the number and types of firearms to be stored in NSW
  - A copy of the registration certificate for every firearm to be stored in NSW
  - interstate firearms licence or permit number or a copy of this licence or permit
  - Letter from your jurisdiction (interstate Firearms Registry) acknowledging that you have notified them of the type and number of firearms to be stored in NSW
  - Fee \$75 (cheque, money order or credit card authority), with the application**
