## Tranquilliser Firearm Permit Legitimate Reason Form

### PLEASE READ THE FOLLOWING INFORMATION PRIOR TO COMPLETING THIS FORM

This is an **interactive** form and applies to an individual, business or organisation who require the use of a firearm, designed for use in tranquillising, immobilising or administering vaccines or other medicines to animals in the normal course of the persons occupation.

Please complete all sections, print this form and submit with the P634 'Application for a Firearms Permit' form and any supporting documentation to the **Firearms Registry, Locked Bag 5102, Parramatta NSW 2124.**

Nominated person for business and individual applicant must attach documentation of Proof of Identity (*if no other NSW firearms licence or permit is held or has been held*). See fact sheet 'Proof of Identity' for documents which are acceptable to prove 100 point ID.

### 1. LEGITIMATE REASON - DETAILS OF BUSINESS / OCCUPATION

The Commissioner must not issue a permit unless satisfied that the applicant has a legitimate reason for the permit. Provide information below on the reason you need to possess and use a tranquilliser firearm that is unique to your specific circumstances.

Provide information below detailing your occupation or business and the purpose for which a tranquilliser firearm is necessary in the course of your business/occupation.

Business applicants must attach evidence (eg. business registration) to prove business status or supply veterinary qualifications and/or if employed attach a letter from your employer which details your need to possess and use a tranquilliser firearm.

Attach evidence of status as a business.

**OR**

Attach Veterinary Practitioner Qualifications, (*if applicable*).

**AND/OR**

A letter from employer (on letterhead) which confirms employment status and your need to possess and use a tranquilliser firearm attached.

### 4. TRANQUILLISER FIREARMS SAFETY TRAINING

If you have never held a tranquilliser firearms permit in NSW, or you do not currently hold an equivalent issued tranquilliser firearms permit, you are required to complete firearm safety training for tranquilliser firearms.

Attach a certificate of successful completion of an approved firearm safety training course for tranquilliser firearms (*if applicable*).





## 5. TRANQUILLISER FIREARM SAFE KEEPING FACILITIES AND REQUIREMENTS

Provide information below on your arrangements for safe keeping and storage of tranquilliser firearms at the firearm safe keeping address nominated in your Firearms Permit application form.

### FURTHER INFORMATION

It is a serious offence under the *Firearms Act 1996* to make a statement or provide information in relation to an application that is false or misleading. By signing the Declaration on your firearms permit application form, you are certifying that ALL the information supplied in relation to this application is true and correct.

**INDIVIDUAL APPLICATIONS: DO NOT SEND PAYMENT WITH THIS APPLICATION** - If approved you will be sent a photographic advice to attend the RTA to have your permit card issued and you will pay at the RTA.

**BUSINESS, ORGANISATION OR CLUB APPLICATIONS: SEND PAYMENT OF \$100 WITH THIS APPLICATION** - If approved, applications being made by a business, organisation or club are produced by the Firearms Registry and posted.

### CHECKLIST - Make sure you have supplied ALL of the following required information:

**All applicants are required to provide:**

- A completed P634** 'Application for a Firearms Permit' form
- Proof of Identity** (if no other NSW firearms licence or permit is held or has been held).
- A Legitimate Reason** form with the relevant sections completed:
  - Legitimate Reason - details of your occupation or business and the purpose for which a tranquilliser firearm is required
  - OR**  Letter from employer which confirms employment status and your need to possess and use a tranquilliser firearm
  - OR**  Veterinary Qualifications
- Tranquilliser firearm details (longarm/pistol)
- Firearm safety training for tranquilliser firearms
- Tranquilliser firearm safe keeping facilities and requirements

**Individual Application - DO NOT SEND PAYMENT WITH THIS APPLICATION**

If approved you will be sent a photographic advice to attend the RTA to have your permit card issued.

- Business, Club, Organisation - Fee \$100 (cheque, money order or credit card authority), with the application**

**Business Applicants Only** - A completed P635 for each person to be authorised by this permit AND proof of identity for each person (if no other NSW firearms licence or permit is held or has been held) AND Safety Training Certificate.
