### 2. EVIDENCE OF GENUINE REASON FOR OBTAINING THIS PERMIT

Provide information below to support your application to be authorised as a theatrical weapons armourer.

- Re-applications for a theatrical weapons armourer permit must provide documentary evidence of business activities as a theatrical armourer for a significant proportion of the term of the previous permit.





### 3. WEAPON SAFE KEEPING FACILITIES AND REQUIREMENTS

Provide information below on your arrangements for safe keeping and storage of the weapon at the safe keeping address nominated in your 'Application for a Prohibited Weapon Permit' P638 form.

You must have your safe storage location inspected by local police. Police will give you an event number when your safe storage inspection is passed. The event number must be provided below. If the testing of prohibited weapons on the premises is required, the inspection by police must also inspect & pass the testing facilities to ensure the safe conduct of such testing.

### FURTHER INFORMATION

It is a serious offence under the *Weapons Prohibition Act 1998* to make a statement or provide information in relation to an application that is false or misleading. By signing the Declaration on your weapons permit application form, you are certifying that ALL the information supplied in relation to this application is true and correct.

**CHECKLIST** - All applicants are required to provide:

- A completed P638** 'Application for a Prohibited Weapon Permit' form.
- Proof of Identity** (*if no other NSW firearms licence or firearms or weapons permit is held or has been held*).
- Individual applicants** - A passport sized colour photo of yourself endorsed and signed on the back by a JP or serving police officer '*This is a true photo of NAME*'.
- Business Applicants** - Completion of the Business Declaration
- A Genuine Reason** form with the relevant sections completed.
  - Details of the weapons type, quantity and description.
  - Evidence of your genuine reason for obtaining a permit.
  - Safe storage inspection event number.
  - Details of the safe keeping arrangements for the weapon.
- Payment of \$127 MUST accompany this application.**

**Employees** - A completed P639 for each person to be authorised by this permit AND proof of identity for each person (*if no other NSW firearms licence or permit is held or has been held*) AND payment of \$25 per person.
