Exemption Notification - Posted to NSW from Other Jurisdictions

PLEASE READ THE FOLLOWING INFORMATION PRIOR TO COMPLETING THIS FORM

A person who holds an interstate firearms licence and who is a resident of NSW as a result of being posted to a position in NSW or is required to reside in NSW as a condition of employment, is exempt from the requirement to be authorised to possess or use a firearm of a kind to which a corresponding NSW category A, category B or category H licence applies, provided the person notifies the Firearms Registry in writing of their NSW residential address and firearm safe keeping address within 30 days after becoming a resident of NSW. Completion of this form satisfies the notification requirement in accordance with clause 125 of the *Firearms Regulation 2017*.
