FIREARMS SAFETY TEST AND FIREARMS SAFETY TRAINING COURSE

Information regarding the Firearms Safety Test and the Firearms Safety Training Course can be found in the Training and Accreditation Framework for Armed Guards.

These assessments are designed to evaluate the essential marksmanship and firearms handling skills required for officers in the security industry. E mployers have the option to purchase a scoring target from an approved supplier. Alternatively, they can submit a target for approval as part of their application, which should include details of its size and scoring areas.

All specifications must conform to the standards set by the Firearms Safety Test and Training Course.
