Following an authorisation given under s 6 of the *Terrorism (Police Powers) Act 2002* by me the Commissioner of Police at 21:36 on 14 December 2025:

I, Mal Lanyon, Commissioner of Police of the New South Wales Police Force, declare that the following areas are areas in which the authorisation of holding of public assemblies is restricted:

1. The Central Metropolitan Police Region, The Northwest Metropolitan Police Region, The Southwest Metropolitan Police Region.

In making this declaration, I am satisfied that the holding of public assemblies in the area to which this declaration applies would be likely to cause:

1. A risk to community safety, including the safety of participants in public assemblies in the areas.

In extending this declaration, I am satisfied that the holding of public assemblies in the areas to which this declaration applies would be likely to cause:


