| Duplicate/replacement licence | N/A | \$75 | Service NSW when licence produced |

* A pensioner fee exemption is afforded to category A, B, H and probationary pistol licences only

* A primary producer fee exemption is afforded only to applicants with the sole genuine reason of primary production

* Primary producers and pensioners afforded an exemption (as above) are exempt from a fee for a duplicate licence

* Any composite licence - the higher fee applies

No fee applies to a change of residential or safe storage address on an individual licence

* Fees paid are listed in Australian dollars and no GST is applicable on any fees

* **Fees paid online** via the NSW Police Force Community Portal are paid by credit card (Visa or Mastercard)

* **Fees paid to the Firearms Registry** can be paid by credit card authority on the application form (NO CASH)

* Where insufficient funds or a required payment is not provided, your application will be delayed

* If a receipt is required for taxation purposes, please submit the request in writing

* If payment is made separately to the application, please include identification details e.g. name, licence number etc

Pension fee exemption (*not available for all application types*):

To claim a fee exemption as a pensioner, you will need to provide a copy of one of the following acceptable cards:

- Centrelink pension concession card,
- Disability support pension card
- Department of Veterans' Affairs card (including concession and health care cards)
