# Welcome:

Sergeant Cattell introduced himself and other police members present, including Superintendent MCCUSKER to the attendees and thanked everyone for their attendance.

### **CPSM Meetings:**

The minutes from the previous CSPM Meeting 29.09.2016 were introduced, nil issues or concerns. Minutes were adopted by Sergeant Cattell and seconded by Senior Constable Leo.

Senior Constable Leo introduced herself and explained the role of Crime Prevention Officer to the attendees and the purpose of the meeting to encompass an opportunity for community leaders and reps to provide feedback, identifying new issues within the community and developing solutions for the new concerns, to provide strategies through social constructs, and to improve public safety and reduce fear of crime, to raise understanding between policing and crime reduction.

Superintendent McCusker introduced herself to the attendees and gave a background history as the Commander of this Local Area Command and other LACs.

### **Current Issues:**

Northwest Mascot is experiencing Break and Enter Dwelling including (underground garages) due to development of residential and commercial properties. *Crime prevention strategies* for this are being implemented are letter box drops regarding safety tips, safety audits and tasking.

Steal From Dwelling (Mail theft) is high within the Northwest Mascot area but this increase is throughout the whole Local Area Command and Region. *Crime prevention strategies* are being implemented are safety audits, letter box drops, BBLAC Facebook page with sharing safety tips, new DA recommendations for mailbox's to be built internally.

#### Steal from Retail – Eastgardens

*Crime prevention strategies* are being implemented are increased shoplifting operations, better CCTV utilised and Facebook circulation of suspects.

Domestic Violence, Malicious Damage and Stealing Offences prominent in the Botany area for the period

Crime prevention strategies being implemented are Domestic Violence STMP Operations being run, Targeted action, management plans for Domestic Violence offenders, taskings, letter box drops and safety audits.

What requirements are needed for CCTV footage?

### Action:

Mr Hammond was advised that In most cases an event has happened RE: Shoplifting / Missing Person, CCTV is required to identify the shoplifter, if shoplifter is unknown to Police, after all procedures, processess and legal requirements are made, the Duty Officer will download footage on Botany Bay LAC Facebook account to ask for the communities help to identify suspect.

Mike Mahendran asked that Police collect footage before 2 week period as the systems deletes and could expire

**Graffting Tagging**, is it beneficial to contact Police or Police Assistance Line or is it a hinderance?

#### Action:

No, it is not a hindrance, it is beneficial to report these incidents as little incidents can turn into bigger incidents. Call the Police Assistance Line 131 444 to report, police will attend and take CCTV footage and photos of the tag to build a case against the POI.

# Action:

The Youth Liaison Officer runs a Principal Forum which discuses the school challenges and traffic issues, feedback from the school gets passed to the Police to patrol.

Young Persons Act has a new Act, where they can be charged for certain incidents.

Westfield having problems with school children at Bus Interchange and in Westfield in school hours in school uniform.

# Action:

School Liaison Officer – Snr Cst Rachael Martin will ask to have meeting with the schools to address the issues Westfield and Southpoint are having. Can the schools

have a rule that no student is allowed in Uniform in school hours to attend the shopping precedent?

Snr Cst Martin to speak to High School Principals in the Command and forward information on to CPO Snr Cst Leo to update Westfield and Southpoint

# Action:

NSW Ports are looking at increasing CCTVs, Closing the Ports with gates and access only by swipe cards. Security are doing more patrols and taking photo's Vehicle Registration Community are not permitted to take photos of Port Botany and Security as asking the POI to delete the photos and are taking photos of poi.

Commander McCusker to speak with Highway as it will be a joint operation
