**Information/Requirement for Probationary Pistol Licence (PPL) holders only:**

- \* No PTA will be issued for the first six months of the licence and only two PTA's will be issued in the second six months of the licence. Within the second six months, you may make application to acquire a combination of any two handguns, with the exception that you not possess a centrefire and a rimfire pistol at the same time - Section 31(3B) of the *Firearms Act 1996*.
- \* With this application you must attach a copy of the Completion Certificate Pistol Firearms Safety Training (PPL) Course issued to you by your club when you successfully complete the Pistol Safety Training Course - Section 16A(2)(b) of the *Firearms Act 1996*.

**Information/Requirement for Category H (Sport/Target Shooting) licence and Probationary Pistol Licence (PPL) holders:**

**Club Confirmation** - If you are applying to acquire a handgun/s for sport/target shooting, this section must be completed by an authorised club official (who is not the applicant).

In accordance with section 31(3A) of the *Firearms Act 1996*, the Commissioner must not issue a permit authorising a person who is the holder of a category H (sport/target shooting) licence (including a probationary pistol licence) to acquire a pistol unless the application for the permit is supported by a written statement by the secretary or other relevant office holder of the pistol shooting club in respect of which the person's genuine reason for having the licence has been established -

- (a) confirming that the person has adequate storage arrangements in relation to the safe keeping of the pistol, and
- (b) specifying the shooting activities for which the pistol is required.
