### **Matters for 2018**

Of the 14 matters noted in Table 1, all have final court outcomes.

Of those outcomes, there were a total of 29 charges finalised.

Of those charges, 15 were found not guilty. 8 were found guilty but no conviction was recorded, 6 were found guilty and convicted.

### **Matters for 2019**

Of the 11 matters noted in Table 2, 6 are still before the court and 5 have court outcomes.

Of those with outcomes, there were a total of 11 charges finalised.

Of those charges, 10 were found not guilty. 1 was found guilty but no conviction was recorded
