NOTE

Please read this information before completing the application form.

- 1. To be granted a tattooing show permit you must satisfy all eligibility requirements including:
 - you must be an individual and at least 18 years of age;
 - you must be an Australian citizen or permanent Australian resident (includes New Zealand citizens);
 - you must not be a controlled member of a declared organisation under the Crimes (Criminal Organisations Control)
 Act 2012;
 - you must not be a member of a prescribed criminal organisation or have been a member in the previous 12 months before making the application.
- 2. No more than two (2) permits may be granted in the same calendar year to the same individual, or an individual applying on behalf of the same corporation, partnership or trust.
- 3. A tattooing show permit is granted for a period of not more than seven (7) days.
- 4. If the proposed tattooing show will be conducted on behalf of a corporation, partnership or trust, the application must be made by an individual nominated by the corporation, partners or trustees to be the Events Manager for the show. In such instances, a P1253 Nomination of Events Manager for a Tattooing Show form must accompany this application.
- 5. Body art tattooing procedures may only be performed at a permitted tattooing show by an individual who:
 - holds a current NSW Tattooist licence; or
 - holds a current NSW Master licence for premises at which the individual performs body art tattooing procedures as a self-employed individual; or
 - holds a current NSW Visiting Tattooist Permit; or
 - is an authorised participant of the show.
- 6. An individual is an *authorised participant* of a tattooing show if the personal details of the individual are notified to the Security Licensing & Enforcement Directorate (SLED) by the permit holder at least 14 days before the commencement of the proposed tattooing show, and the individual satisfies all eligibility requirements including:
 - is at least 18 years of age;
 - is not a controlled member of a declared organisation under the Crimes (Criminal Organisations Control) Act 2012;
 - is not a member of a prescribed criminal organisation and was not a member of a prescribed criminal organisation in the previous 12 months; and
 - has not, in the previous 12 months, been an authorised participant of more than one (1) other tattooing show.
- 7. An individual stops being an *authorised participant* of a tattooing show if:
 - the Commissioner of Police gives written notice to the permit holder for the show stating that the individual is not to be an *authorised participant* of the show, or
 - the individual becomes an unsuitable individual, or
 - the permit holder gives written notice to the Commissioner of Police that the individual is no longer to be an authorised participant of the show.
- 8. The following details of each individual proposed to perform body art tattooing procedures at the tattooing show must be provided with this application to enable the application to be considered.

9. Any changes to the *authorised participants* of the tattooing show provided with this application must be notified to SLED at least 14 days before the commencement of the proposed tattooing show. The changes must include the personal details of the *authorised participant* as listed in Note 8 (above).

- 10. Applicants must be able to demonstrate their capacity to ensure that participants comply with any applicable legislation relating to the performance of body art tattooing procedures including the *Public Health Act 2010* and the *Public Health Regulation 2022*. These provide the legislative requirements for body art tattooing in NSW in relation to hygiene standards, infection control, premises standards and equipment. For more information on public health legislation and regulations affecting body art tattooists, see the Body art and tattooing businesses fact sheet on the NSW Health website at www.health.nsw.gov.au.
- 11. All documentation accompanying your application that displays your name must show your name written and spelt in exactly the same way (unless you provide acceptable documentary evidence of a change of name).
- 12. Fully completed application forms and accompanying documents must be received by SLED <u>at least 28 days before the proposed starting date for the tattooing show.</u>
- 13. All applications and attachments, including details of participants, must be posted to SLED or submitted via another agreed method. For more information, contact SLED on 1300 362 001 (8:30 am to 4:30 pm Monday to Friday excluding public holidays) or via sled@police.nsw.gov.au.
