The following information relates to persons warned, charged or convicted under s93X of the Crimes Act 1900 between 9 April 2012 and 15 April 2015

Question 1 Persons arrested (charged)

Between 9 April 2012 and 15 September 2015, 48 people have been charged – issued with a Court Attendance Notice (CAN) - for consorting under s93X of the *Crimes Act 1900*.

Question 2 Persons convicted

Of the 48 people charged, 33 so far* have received a finalised court result.

Of these, 23 have had a conviction recorded, including 2 that are now appealing.

Where a person has been charged more than once in the same year, they have only been counted once for that year. In total the 48 people charged had 55 CANs issued against them for consorting.

Question 3 Persons warned

In June 2013, amendments were made to the NSW Police Force Computerised Operational Policing System (COPS) to increase the accuracy of consorting recording.

For all incidents recorded prior this date (i.e. between 9 April 2012 and 23 June 2013), there is an undercount for the number of 'persons warned', due to the way the data was recorded and can be extracted for those dates.

There will also be some variation between these statistics, and those previously supplied to Parliament (due to the evolving count methods used across periods), and also those expected to be published in the NSW Ombudsman's two year review of the consorting legislation. In regards to the latter, the Ombudsman's project team read individual COPS event narratives for all potential consorting warnings, and as a result will be able to produce statistics that are less affected by any changes in recording or reporting procedures across time.
