DISPOSAL OF FIREARMS

If you are deleting a category or genuine reason on your existing firearms licence, you must dispose of any firearms related to that category, unless you remain authorised for those firearms by another genuine reason/category. For example, if you delete category B on Target Shooting, you must dispose of your category B firearms unless you are authorised for category B on another genuine reason, such as Recreational Hunting.

Firearms must be disposed via a licensed firearms dealer and the Firearms Registry must be notified of the disposal details.
