**SAFEGUARD** and **STRENGTHEN** individuals, communities, assets and infrastructure to deter crime, improve personal safety, and build resilience

- Promote safe alcohol consumption practices to reduce alcohol-related harms.
- Increase awareness and understanding of alcoholrelated harms by developing information, tailored to community needs that promote safe consumption and alcohol legislation.
- Working with community partners to improve awareness and understanding of alcohol-related harms including secondary supply (eg Love Bites, ADF Good sports, Outback Rugby League, Tackling Violence, Mission Australia Reconnect, Police Aboriginal Consultative Committees).
- Participate in whole of government and interagency crime prevention and public safety initiatives and programs.
- Proactively apply crime prevention methodology to DA applications with the view to minimise the impact of alcohol on the community and public amenity.
- Advocate for, and participate in, government and interagency campaigns aimed at changing drinking culture.
- Continue to advocate for and implement strategies to increase personal responsibility (fail to quit, binge drinking, sexual assault).
- Continue to work with Roads and Maritime Services to develop, monitor and evaluate strategies aimed at reducing alcohol-related incidents on NSW roads, particularly in regional and at-risk areas.
- Promote alternative transport options and campaigns to reduce drink driving.

#### **INTERVENE EARLY** for at risk individuals and groups to limit escalation, minimise harm and positively influence behaviour

- Provide at risk communities and individuals with support, education and advocacy to address alcohol-related issues.
- Strengthen community partnerships and proactively engage with individuals, groups and communities at risk of alcohol-related harm (eg attending and presenting at local meetings such as Council safety committees, Men's Shed, Elders meetings).
- Promote and utilise available funding to develop and deliver appropriate programs / initiatives that target "at risk" individuals and communities (ASD Crime Prevention Grants fund, Drug Summit Grants program, LDATs funding).
- Support and participate in Community Drug Action Teams (CDATs) and Local Drug Action Teams (LDATs) to build the capacity of local communities to develop local solutions for alcohol-related harms.
- Work in partnership with Liquor Accords to develop practical solutions to alcohol-related problems (e.g. Maitland Liquor Accords Safer Nights Out Project, Ask Angela, Cup of Tea).
- Work with other agencies to provide information and education about the harms associated with excessive alcohol consumption by young people (e.g. Secondary Supply, international students).

**DIVERT** minor offenders and at-risk groups (e.g. young persons, Aboriginal people) to reduce reoffending and avoid unnecessary contact with the criminal justice system

- Improve and increase referrals to alcohol diversionary programs.
- Increase police use of appropriate diversion programs / interventions which address alcohol misuse such as MERIT, Your Choice, Fit for life, PCYC.
- Improve police interventions around alcohol misuse for juvenile offenders.
- Advocate for, and investigate opportunities to expand alcohol diversion programs
- Refer alcohol-related perpetrators of domestic and family violence to appropriate service where they can access treatment programs for alcohol misuse (Men's Referral Service, DVSTMP).

#### ENVIRONMENTAL SCANNING SNAPSHOT Potential crimes and threats in emerging technologies:

• COVID-19 and the related Public Health Orders (PHO) contributed to a significant reduction in crimes that are enabled by public mobility and gatherings. There has been a reduction of offences involving violence and/or intoxication in licensed premises, particularly with the complete shutdown of licensed premises and music festivals and lower patronage levels on reopening. Whilst it is difficult to predict what will happen to the occurrence of assaults generally with NSW out of lockdown an increase in offending is expected.

	Encourage individual agencies to employ staff to ensure the safety of public transport hubs, such as the taxi council and transport for NSW. Public spaces should be designed to discourage loitering of groups, is well lit and covered by CCTV cameras. Encourage the council to provide access to public amenities to discourage anti-social behaviour. These may include toilets to discourage public urination, drinking fountain to reduce the effects of alcohol and rubbish disposal to create a safe and clean space. Encourage the council and local business chambers to implement outdoor dining (space permitting) to create a sense of community. Promote the use of public spaces with community events and street performers (VIVID, food markets) which encourage social cohesion. Encourage the local council to deploy "way finders" to assist in the movement of pedestrians. Work with Local Councils for establishment and reestablishment of alcohol free zones. Utilise powers under the Liquor Act for example, section 78 allows a banning order to prevent an individual from entering or remaining on a licenced premises specified in that order for up to 6 months. #### INTERRUPT criminal behaviour to break criminal networks and bring offenders to justice

- Identify, target and DISRUPT problematic business models in the liquor industry to eliminate potential problems before they emerge and escalate.
- Use appropriate legislation to strategically manage poor or problematic business practices of licensed premises.
- Continue to apply for banning orders to bar troublesome patrons who demonstrate violent or significantly inappropriate behaviour from licensed premises.
- Manage 3 strikes process, with focus on individual or suboptimal business practices.
- Maintain focus upon the Violent Venues Scheme.
- Use licensing legislation to target and disrupt organised crime activities where appropriate (e.g. karaoke bars, club houses and gaming machines).
- Work with Liquor Accords to influence patron standards (e.g. dress codes, soft colours).
- Effectively manage compliancerelated matters.

- Enhance working relationships with key stakeholders (liquor industry, L&GNSW, ILGA, Local Council, AHA, Clubs, Liquor Stores Association.
- Provide Community Impact Statements in consultation with the CPU and community where there are concerns that applications to establish new licenced premises or packaged outlets may adversely

impact communities.

- Assess licence authorisations and applications for appropriateness to minimise potential misuse and
- Abuse of licence types (e.g. on-premise licence, caterer's authorisation).
- Assess transfer applications to ensure applications are appropriately screened and vetted.
- Work with L&G NSW to address challenges associated with packaged liquor outlets including online purchases and deliveries.
- Actively participate in Liquor Accords to influence safe licensing and management practices.
- Include alcohol-related crime within planning and post operation reviews (e.g. planning checklist).
- Work with Local Councils to encourage, where appropriate, the establishment of additional defined areas (precincts) where licensed premises face special trading rules designed to make venues, neighbourhoods and transport safer (e.g. Communication between venues, Alcohol Free Zones, safer transport options).
- Regular and ongoing audits of licensed premises are conducted and recorded, to provide an evidentiary record of events used in compliance and enforcement proceedings (e.g. CPTED, CCTV, Glass, Incident Register, PoM).


