NOTE
Please read this information before completing the application form.

- To apply for a visiting tattooist permit you must:
 - be an individual;
 - be at least 18 years of age;
 - NOT be an Australian citizen or permanent Australian resident (includes New Zealand citizens).
- The application may be refused if:
 - it was not properly made; or
 - you are not a fit and proper person to be granted a permit; or
 - a close associate of you is not a fit and proper person; or
 - it would be contrary to the public interest for you to be granted a permit; or
 - you have, within the period of 10 years before the application was made, been convicted in NSW or elsewhere of a disqualifying offence, whether or not the offence is an offence under NSW law; or
 - you are a member of a prescribed criminal organisation (as listed in Schedule 3 of the *Tattoo Industry Regulation 2023*); or
 - you were a member of a prescribed criminal organisation within the 12 months before making the application.
- No more than two (2) visiting tattooist permits may be granted to the same individual in the same calendar year.
- Visiting tattooist permits may only be granted for a maximum period of three (3) months.
- Applications must be received by the Security Licensing & Enforcement Directorate (SLED) at least 28 days before the proposed commencement date for the permit.
- All documentation accompanying your application that displays your name must show your name written and spelt in exactly the same way.
- Incomplete applications will not be considered.

5 DECLARATION AND CONSENT

apply for the grant of a visiting tattooist permit under the *Tattoo Industry Act 2012* and:

- certify that the information contained in this application, and any attachments, are true and correct in every detail;
- understand that giving false or misleading information is a serious offence;
- consent to the disclosure by the relevant authority of information needed to verify any details I have given in this application;
- consent to and do request Australian Police agencies to release, to the NSW Police Force, information held by any of them regarding any convictions, findings of guilt (either with or without conviction) and any matters still outstanding against me and any other matters deemed relevant that are recorded against me, whether in my current name or a previous name;
- authorise disclosure to the NSW Police Force by New Zealand Police of ANY information that may be held by NZ Police, including any interaction I have had with NZ Police in any context or any information received by NZ Police. I understand that this is not limited to conviction information. Where that information relates to any record of criminal convictions I might have, I understand that it will automatically be concealed if I meet the eligibility criteria stipulated in section 7 of the *NZ Criminal Records (Clean Slate) Act 2004*;

- undertake to comply with all legislative requirements applicable in the State of NSW relating to the performance of body art tattooing procedures; and
- have supplied credit card details for the correct application fee.
