NOTE

Please read this information before completing the application form.

- 1. To apply for a visiting tattooist permit you must:
 - · be an individual;
 - be at least 18 years of age;
 - NOT be an Australian citizen or permanent Australian resident (includes New Zealand citizens).
- 2. The application may be refused if:
 - it was not properly made; or
 - you are not a fit and proper person to be granted a permit; or
 - a close associate of you is not a fit and proper person; or
 - it would be contrary to the public interest for you to be granted a permit; or
 - you have, within the period of 10 years before the application was made, been convicted in NSW or elsewhere of a disqualifying offence, whether or not the offence is an offence under NSW law; or
 - you are a member of a prescribed criminal organisation (as listed in Schedule 3 of the *Tattoo Industry Regulation* 2023): or
 - you were a member of a prescribed criminal organisation within the 12 months before making the application.
- 3. No more than two (2) visiting tattooist permits may be granted to the same individual in the same calendar year.
- 4. Visiting tattooist permits may only be granted for a maximum period of three (3) months.
- 5. Applications must be received by the Security Licensing & Enforcement Directorate (SLED) at least 28 days before the proposed commencement date for the permit.
- 6. All documentation accompanying your application that displays your name must show your name written and spelt in exactly the same way.
- 7. Incomplete applications will not be considered.
