6. OVERVIEW OF CURRENT CRIME TRENDS Discussed by Crime Manager- A/Inspector Brett Van Akker

- Assaults (Non DV) increased for 10.6%
- Robberies increased for 38.5%
- Steal from person decreased for 61.1%
- Break and Enter from Dwelling decreased for 24.2%
- Steal from Dwelling increased for 13.6%
- Break and Enter (non Dwelling) decreased for 38.7%
- Malicious Damage decreased for 9.3%
- Stolen vehicles decreased for 8.5%
- Steal from motor vehicles decreased for 18.8%
- Steal from retail store increased for 3.0%
- NSW Police is encouraging people to report crime (Domestic and non-Domestic related crime).
