## PROHIBITED WEAPONS THEATRICAL ARMOURER PERMIT

This FACT Sheet provides information on the requirements for obtaining a Theatrical Weapons Armourer Permit - section 8 & Part 3 of the *Weapons Prohibition Act 1998* and part 5 of the *Weapons Prohibition Regulation 2017*.

It is an offence in NSW to possess a prohibited weapon without the authority of a permit.

### What does the Theatrical Weapons Armourer Permit authorise?

This permit authorises the permit holder, and any authorised employee, in the course of carrying on a business as a theatrical weapons armourer:

- To possess, use, buy, sell and manufacture prohibited weapons of the type specified in the permit, and
- To supervise and train persons who are involved in a cinematographic, television or theatrical production in the use of prohibited weapons to which the permit relates.

This permit also authorises persons over the age of 18 years who are involved in the production concerned to possess and use prohibited weapons to which the permit relates, but only while under the direct supervision of the permit holder or an authorised employee.

NOTE: Any person involved in the production who is under the age of 18 years must obtain authorisation in writing from a parent or legal guardian and <u>authorisation in writing from the Commissioner</u> prior to possessing or using the prohibited weapons for the production concerned.

#### What is the term of the permit?

The permit will be issued for a maximum term of 5 years.

#### How much will the permit cost?

The prescribed fee for this permit is \$127. <u>Your payment must accompany the application</u>. Please complete the credit card details on the reverse of the application form. An additional \$25 fee is required for each person, other than the permit holder, completing a P639 form to be listed and authorised by the permit.

#### What do I need to send with the application?

- A completed P638 'Application for a Prohibited Weapons Permit' form, and
- A completed 'Theatrical Weapons Armourer Genuine Reason' form, and
- A completed 'Business Declaration', and
- Supporting documentation as requested on the genuine reason form.

#### What kind of prohibited weapons are authorised by this permit?

There is no restriction on the type of prohibited weapons which may be authorised by this permit. However, you must be able to justify that possession and use of the weapons is required in connection with the genuine reason for obtaining a prohibited weapon permit. You must nominate the type of prohibited weapon on the relevant Genuine Reason form for the type of permit concerned.

#### What safe keeping level applies to this permit?

See the FACT Sheet 'Safe Storage Prohibited Weapons Level 1, 2 & 3' & 'Prescribed Safe Storage for Schedule 1 Prohibited Weapons' for the storage level that applies to the weapons nominated for your permit.

You must meet or exceed the prescribed safe storage for the weapon concerned.

#### What about employees?

A person who is an employee of the permit holder, or person who is engaged in the operation of the practice or organisation of the permit holder, may make application to be listed on and authorised by this permit. Each employee must complete an 'Application for a Person to be Authorised on a Prohibited Weapons Permit' P639 form. A separate P639 form must be used for each person wishing to be authorised by the permit.

All applicants must provide proof of identity totalling 100 points (if the person <u>does not</u> hold a current licence or permit). There is a prescribed fee of \$25 for each person in addition to the permit holder to be listed on the permit.

#### How do I apply for a Theatrical Weapons Armourer Permit?

You must complete the P638 'Application for a Prohibited Weapons Permit' form and the 'Theatrical Weapons Armourer Genuine Reason' form and where applicable provide any supporting documentation.

## **PROHIBITED WEAPONS PERMIT APPLICATION FORM (P638)**

## NEW APPLICATION / REAPPLICATION

Mark the appropriate box, new application or reapplication. If you currently hold, or have previously held, a firearms licence or firearms or prohibited weapon permit, enter your licence or permit number.

## **SECTION A - PERMIT TYPE**

From the drop-down list select the type of permit for which you are applying. If the permit is not listed in the drop-down list, enter 'Other' and describe the type of permit you require in the space provided.

## SECTION B - NOMINATED PERSON / PERMIT HOLDER

Insert the full name, date of birth, gender, NSW drivers licence (if held), contact phone numbers, email address and supply details for the nominated person (business) or nominated permit holder (individual). If you have been known by any other names enter your alias here.

## SECTION C - RESIDENTIAL ADDRESS

Insert your full residential address in this section.

### **SECTION D - POSTAL ADDRESS**

If the postal address is the same as the residential address, mark the box. If your postal address is different to your residential address, insert your postal address in this section.

## SECTION E - BUSINESS, CLUB OR GOVERNMENT AGENCY DETAILS

If this application is being made by a Business, Club or Government Agency, complete this section and attach supporting documentation.

## SECTION F - SAFEKEEPING ADDRESS OF WEAPONS

If the safekeeping address is the same as the residential address, select 'YES' in the box. If your weapon safekeeping address is different to your residential address, select 'NO' and insert the address in this section.

### **SECTION G - PERSONAL HISTORY**

Answer each question by selecting a 'YES' or 'NO' from the drop-down list. If you answer 'YES' to any question, provide details as an attachment.

### **SECTION H - DECLARATION**

The application must be signed and dated by the applicant.

### **SECTION I - FEE**

The prescribed fee for a prohibited weapon permit is \$127. Your payment must accompany the application.
